Dear Star Spangled Spectacular Food Booth Organizer,

We are excited to move forward with the SSS this year, after last year's cancellation due to COVID-19. ***At this time, the SSS Committee has requested one COVID-19-related modification to the event, and that modification is for vendors to wear masks.***

As in prior years, we would like booths to serve food both the evening of July 3 in Sunset Park and the usual locations on July 4. If you want a booth, you will get our "early bird special" of \$75 if you have your fully completed application and check back to me by *June 1*. If your application is sent to me after June 1, the fee is \$90. ***Returning food booths from 2019 will only be guaranteed the same location if payment and completed registration are in by June 1.***

Please be sure to fill out the section on the bottom of the application that asks you to list the menu that you are serving. This provides the information necessary for the newspapers to let everyone attending know that you will be having a booth and what goodies they can plan to buy from you. We would also encourage you to have a poster at your booth explaining what project the proceeds will be going towards. Again, as a reminder, there will be no games of chance, skill or raffles or sale of any items other than food.

Your name will be submitted to the BV County Environmental Health Department. Your organization **MUST** comply with the county department requirements, including the purchase of a food permit for \$50. The Health Department is located in the basement of the BV County Courthouse. The Temporary Food Establishment Application can be obtained at the website: bvcountyiowa.com/index.php/environmental_health/food_food_service_establishment. I will send more information regarding set-up times, etc, after I receive your application. Since the 4th is on a Sunday this year, the parade will start at 11:30am.
